Mr. Blauvelt called the meeting to order and said that it had been called to consider a tax matter.

Mr. Dickenman moved the following resolution:

WHEREAS, the item of \$9,335.99 shown on the County Treasurer's statement for the year ending October 31, 1943, is subject to a debit charge of the Town Welfare Charges at the County Welfare Home amounting to \$7,780.81 as per County Treasurer's letter dated November 8, 1943, which would make a net credit balance for the township of \$1,555.18 which may be applied as a credit to reduce current taxes and

WHEREAS, Resolution of November 12, 1943, inadvertently applied the whole credit, therefore, be it hereby
