RESOLUTION NO. (367-1999)

Co. Mandia offered and Co. Profenna seconded

WHEREAS, the Town Board of the Town of Clarkstown, by Resolution No. 515 adopted on June 9, 1998, granted Anthony Capasso a special permit to conduct a landfill operation on property located on the East side of Pascack Road and the North side of Will Rogers Lane, in the Hamlet of Nanuet, more particularly described on the Clarkstown Tax Map as Map 5, Block A, Lot 27, and

WHEREAS, the aforesaid resolution contained a series of conditions as part of said permit which Anthony Capasso was obliged to comply with, and

WHEREAS, it is alleged that Anthony Capasso has not complied with all the conditions of the special permit to conduct a landfill operation, and

WHEREAS, the Town Board, by Resolution No. 364 adopted on April 27, 1999, suspended Anthony Capasso's fill permit;

NOW, THEREFORE, be it

RESOLVED, that the Town Board of the Town of Clarkstown hereby directs the Department of Environmental Control to prepare a survey of the subject property to determine the limit of disturbance as a result of the landfill operation; to determine whether the existing grade as it presently exists is in accordance with the Pelham West Channel Improvement Plan, and to determine whether the landfill material is in excess of that which is necessary to fill the site in accordance with the Pelham West Channel Improvement Plan, and be it

FURTHER RESOLVED, that the Department of Environmental Control shall conduct such examination as it deems necessary to determine whether the material used in the fill operation is in conformity with the special permit granted pursuant to Resolution No. 515 of June 9, 1998.


