

NOTICE OF SPECIAL ELECTION

CONGERS FIRE DISTRICT, IN THE
TOWN OF CLARKSTOWN,
ROCKLAND COUNTY, NEW YORK

NOTICE IS HEREBY GIVEN that a Special Election of the qualified voters of the Congers Fire District (hereinafter called the "Fire District"), in the Town of Clarkstown, Rockland County, New York, will be held at the fire house located on 40 North Harrison Avenue, Congers, New York, in said Fire District, on Tuesday, July 2, 2013. The polls shall open at 6:00 o'clock P.M. (Prevailing Time) and shall remain open until 9:00 o'clock P.M. (Prevailing Time) or as much longer as may be necessary to enable the voters then present to cast their votes.

NOTICE IS HEREBY FURTHER GIVEN that pursuant to the resolution adopted by the Board of Fire Commissioners of the Fire District on May 20, 2013, the following Proposition will be submitted to the qualified voters of the Fire District for approval or disapproval:

PROPOSITION

SHALL the bond resolution of Congers Fire District, in the Town of Clarkstown, Rockland County, New York, entitled: "BOND RESOLUTION OF THE CONGERS FIRE DISTRICT ("FIRE DISTRICT"), IN THE TOWN OF CLARKSTOWN, NEW YORK, ADOPTED MAY 20, 2013, AUTHORIZING THE PURCHASE OF A SPARTAN MID-MOUNT TOWER LADDER FIRE TRUCK, INCLUDING EQUIPMENT AND APPARATUS USED IN CONNECTION THEREWITH, FOR USE BY THE FIRE DISTRICT; STATING THE ESTIMATED MAXIMUM COST THEREOF IS \$1,008,505; APPROPRIATING \$1,008,505 THEREFOR, INCLUDING THE APPROPRIATION OF NOT TO EXCEED \$58,505 FROM THE EXISTING "CAPITAL RESERVE FUND FOR FIRE APPARATUS" AND THE AMOUNT OF ANY PROCEEDS FROM THE SALE, HEREBY

AUTHORIZED, OF THE 1996 KME MID-MOUNT 95' TOWER LADDER TRUCK WITH THE 2000 GPM PUMP NOW OWNED BY THE FIRE DISTRICT AND DETERMINED TO BE NO LONGER NECESSARY FOR ANY OF ITS USES OR PURPOSES; AUTHORIZING THE ISSUANCE OF NOT TO EXCEED \$950,000 SERIAL BONDS TO FINANCE THE BALANCE OF SAID APPROPRIATION; DETERMINING THAT THE PERIOD OF PROBABLE USEFULNESS OF SAID SPECIFIC OBJECT OR PURPOSE FOR WHICH SAID SERIAL BONDS ARE TO BE ISSUED IS 20 YEARS; FURTHER DETERMINING THAT, PURSUANT TO THE STATE ENVIRONMENTAL QUALITY REVIEW ACT ("SEQRA"), THE PURCHASE AND USE OF SAID TOWER LADDER FIRE TRUCK IS A TYPE II ACTION AND DOES NOT REQUIRE ANY FURTHER REVIEW, AND PROVIDING FOR THE LEVY OF TAXES TO BE COLLECTED TO PAY THE PRINCIPAL OF AND INTEREST ON SAID BONDS," BE APPROVED?

All residents of the Fire District who were duly registered to vote with the Rockland County Board of Elections on or before June 10, 2013, shall be eligible to vote at said Special Election.
