


NOTICE OF SPECIAL ELECTION

NANUET FIRE DISTRICT, IN THE
TOWN OF CLARKSTOWN,
ROCKLAND COUNTY, NEW YORK

NOTICE IS HEREBY GIVEN that a Special Election of the qualified voters of the Nanuet Fire District (hereinafter called the "Fire District"), in the Town of Clarkstown, Rockland County, New York, will be held at the Nanuet Firehouse located on Prospect Street in Nanuet, New York, in said Fire District, on Tuesday, September 17, 2013. The polls shall open at 6:00 o'clock P.M. (Prevailing Time) and shall remain open until 9:00 o'clock P.M. (Prevailing Time) or as much longer as may be necessary to enable the voters then present to cast their votes.

NOTICE IS HEREBY FURTHER GIVEN that pursuant to the resolution adopted by the Board of Fire Commissioners of the Fire District on August 13, 2013, the following Proposition will be submitted to the qualified voters of the Fire District for approval or disapproval:



PROPOSITION

SHALL the bond resolution of Nanuet Fire District, in the Town of Clarkstown, Rockland County, New York, entitled: "BOND RESOLUTION OF NANUET FIRE DISTRICT ("FIRE DISTRICT"), IN THE TOWN OF CLARKSTOWN, ROCKLAND COUNTY, NEW YORK, ADOPTED AUGUST 13, 2013, AUTHORIZING THE CONSTRUCTION OF A NEW FIREHOUSE ON 2.1 ACRES OF LAND OWNED BY THE FIRE DISTRICT AND SITUATE THEREIN ON OLD MIDDLETOWN ROAD, IN NANUET, INCLUDING GRADING OR IMPROVEMENT OF THE SITE AND PURCHASE OF THE ORIGINAL FURNISHINGS, EQUIPMENT, MACHINERY OR APPARATUS REQUIRED FOR THE PURPOSES FOR WHICH SAID FIREHOUSE IS TO BE USED ("PROJECT"); STATING THE ESTIMATED MAXIMUM COST THEREOF IS \$16,100,000, INCLUDING PRELIMINARY COSTS AND COSTS INCIDENTAL THERETO AND TO THE FINANCING THEREOF; APPROPRIATING SAID AMOUNT THEREFOR; AUTHORIZING THE ISSUANCE OF SERIAL BONDS IN THE AMOUNT OF NOT TO EXCEED \$16,100,000 TO FINANCE SAID APPROPRIATION; STATING THAT THE BOARD OF FIRE COMMISSIONERS, ACTING AS LEAD AGENCY PURSUANT TO THE NEW YORK STATE ENVIRONMENTAL QUALITY REVIEW ACT, HAS DETERMINED THAT THE PROJECT IS AN UNLISTED ACTION AND A NEGATIVE DECLARATION HAS BEEN ISSUED AND FILED; STATING THAT THE PERIOD OF PROBABLE USEFULNESS OF SAID NEW FIREHOUSE IS THIRTY (30) YEARS AND PROVIDING FOR THE LEVY AND COLLECTION OF TAXES TO PAY THE PRINCIPAL OF SAID BONDS AND THE INTEREST THEREON AS THE SAME BECOME DUE AND PAYABLE?

All residents of the Fire District who were duly registered to vote with the Rockland County Board of Elections on or before August 26, 2013, shall be eligible to vote at said Special Election.
