

NOTICE OF ANNUAL ELECTION
MOLESTON FIRE DISTRICT

PLEASE TAKE NOTICE that the Annual Election of the Moleston Fire District will take place on December 10, 2013, between the hours of 6:00 P.M. and 9:00 P.M. at the Hillcrest Firehouse, located at 300 North Main Street (Route 45), Spring Valley, New York for the following purposes:

To elect one (1) Fire District Commissioner for a five (5) year term commencing January 1, 2014 and ending December 31, 2018; and

To elect one (1) Fire District Commissioner for the two (2) year balance of an unexpired term commencing January 1, 2014 and ending December 31, 2015; and

To vote upon the following proposition:

SHALL the bond resolution of Moleston Fire District, in the Towns of Ramapo, Haverstraw and Clarkstown, Rockland County, New York, entitled: "BOND RESOLUTION OF MOLESTON FIRE DISTRICT ("FIRE DISTRICT"), IN THE TOWNS OF RAMAPO, HAVERSTRAW AND CLARKSTOWN, ROCKLAND COUNTY, NEW YORK, ADOPTED NOVEMBER 6, 2013, AUTHORIZING THE ACQUISITION OF TWO PARCELS OF REAL PROPERTY LOCATED AT 372 AND 376 MAIN STREET, SPRING VALLEY, WITHIN THE FIRE DISTRICT (THE "PROJECT"); STATING THE ESTIMATED MAXIMUM COST THEREOF IS \$1,600,000, INCLUDING PRELIMINARY COSTS AND COSTS INCIDENTAL THERETO AND TO THE FINANCING THEREOF; APPROPRIATING SAID AMOUNT THEREFOR; AUTHORIZING THE ISSUANCE OF SERIAL BONDS IN THE AMOUNT OF NOT TO EXCEED \$1,600,000 TO FINANCE SAID APPROPRIATION; STATING THAT THE BOARD OF FIRE COMMISSIONERS, ACTING AS LEAD AGENCY PURSUANT TO THE NEW YORK STATE ENVIRONMENTAL QUALITY REVIEW ACT, HAS HERETOFORE DETERMINED THAT THE PROJECT IS AN UNLISTED ACTION AND A NEGATIVE DECLARATION HAS BEEN ISSUED AND FILED; STATING THAT THE PERIOD OF PROBABLE USEFULNESS OF SAID PROJECT IS THIRTY (30) YEARS AND PROVIDING FOR THE LEVY AND COLLECTION OF TAXES TO PAY THE PRINCIPAL OF SAID BONDS AND THE INTEREST THEREON AS THE SAME BECOME DUE AND PAYABLE," BE APPROVED?"

All residents of the Moleston Fire District, who are duly registered to vote with the Rockland County Board of Elections on or before November 18, 2013 shall be entitled to vote at this election.

Any person desiring to have his or her name appear on the ballot for one of the above offices must have filed a written request, specifying the office by term expiration date for which the name should appear, with the Secretary of the Fire District not later than November 20, 2013.
